It is with great sadness that we inform you of the passing of Maureen Majury, Director of the Center of Excellence for Computing and Information Technology. Maureen passed away on Saturday, November 16, 2019. The Center would like to dedicate the December 2019 edition of Confluence to honor Maureen's memory.

Maureen began her twenty-seven year career here at Bellevue College in December of 1992 beginning in a secretarial role and advancing through several positions to become the Director of the Center of Excellence for Computing and Information Technology in September of 2012. Maureen worked closely with the Washington State Board of Community and Technical Colleges (SBCTC) and was instrumental in working with IT faculty, program managers, and deans throughout the state.

Colleagues who knew Maureen, report that she was an extremely intelligent, one-of-a-kind woman with a sharp wit and a wicked sense of humor. Dr. Amelia Phillips (pictured middle) was recently honored for her achievement of excellence in teaching and learning. She received the 2019 William H. Meardy Faculty Member Award from the Association of Community College Trustees (ACCT) during an awards ceremony on Oct. 18, 2019 in San Francisco. The annual award recognizes exceptional contributions and service among faculty at more than 1,100 two-year

"For me, winning was — as I said in my acceptance speech — 'unbelievable,'" Amelia said, noting her many thanks to everyone who has supported her. "Everyone at my table was confident I would win and it makes me happy to be honored in this way."

A lead faculty member of Highline's Bachelor of Applied Science in Cybersecurity and Forensics, Amelia is a nationally and internationally recognized expert in the field of computer forensics. During her 17 years at Highline, the Seattle resident has served as the chair of the Pure and Applied Science Division at Highline; she has created the International Collegiate Cyber Defense Invitational (ICCDI), has been the regional director for the Pacific Rim Collegiate Cyber Defense Competition (PRCCDC) for 7 years, and hosted the event for 12 years.



When Amelia is not teaching in the classroom, she is mentoring young and nontraditional women students as part of Highline's Women in Cybersecurity (WiCyS) club, which seeks to assist women in traditionally male-dominated cybersecurity and STEM-related professions. She also serves co-chair of the National Initiative on Cybersecurity Education (NICE) Competitions Subgroup and as an external moderator for Namibia University of Science and Technology.

Amelia has been on the Center's Advisory Board for three years and has been involved in many of the organizations work plan activities such as the Women in Leadership Forums, the Securing the Supply Chain Forums, along with providing great knowledge and insight when it comes to career connected pathway programs.








Jamye Wisecup Memorial Scholarship Program/Endowment
